No.AAP.76/2018/Pt/5: Whereas Smti Avisika Baruah, ACS became Approver in Dibrugarh PS Case No.936/2016 and she gave her confessional statement U/S 164 Cr.P.C before the Judicial Magistrate on 03.8.2018 where she disclosed the ways and means by which she procured the job of ACS conducted by APSC by managing the then Chairman, APSC and others.

Whereas Smti Avisika Baruah, ACS, the then Circle Officer, Nazira, Sivasagar was placed under suspension vide No.AAP 76/2018/2 dated 17.03.2018.

Whereas, the suspension period was extended for another 3 (three) months w e.f. 22/04/2019 vide Notification No.AAP 76/2018/91 dated 22/04/2019.

Whereas, considering the seriousness of the case and as the officer has already given her confessional statement regarding procurement of her job by unfair means, it has been decided by the Appointing Authority that re-instatement at this stage may not be in the interest of public service

Now, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti Avisika Baruah, ACS, for another 3 (three) months w.e.f. 22/07/2019 or till further orders, whichever is earlier.


