No.AAP.101/2023/140: Whereas Smti. Akashee Duwarah, ACS (U/S), the then Addl. District Commissioner, Jorhat, was placed under suspension w.e.f. 30.11.2023 vide Notification No: AAP.122/2023/28 dated 30.11.2023;

Whereas, Departmental Proceeding has been initiated against the officer vide Show Cause notice No.AAP.113/2023/1 dated 14.11.2023; and

Whereas, considering the seriousness of the charges, the period of suspension of Smti. Akashee Duwarah, ACS (U/S) was extended subsequently vide Order No. AAP.101/2023/113, dated 14.03.2024; and

Whereas, considering the grave nature of the charges against Smti. Akashee Duwarah, ACS (U/S) and based on the recommendation of the Review Committee, it has been decided by the Disciplinary Authority that reinstatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti. Akashee Duwarah, ACS (U/S), for another period of 3 months w.e.f. 01.06.2024 or till further order.


