Dated Dispur, the 22<sup>nd</sup> of December, 2023

No.AAP.155/2021/Pt2/48: Whereas Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S), the then Deputy Secretary to the Govt. of Assam, Transport Department, was placed under suspension w.e.f. 04.12.2021 vide Notification No. AAP 155/2021/08 dated 15.12.2021, subsequent to his arrest on 04.12.2021 in connection with Vigilance PS Case No.05/2021;

Whereas, Departmental Proceeding was drawn up against Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) vide Show Cause Notice No. AAP 155/2021/210 dated 14.03.2022;

Whereas considering the seriousness of the charge, the period of suspension of Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) was extended subsequently vide Order no.s: AAP. 155/2021/214 dated 22.03.2022, AAP.155/2021/226 dated 12.07.2022, AAP.155/2021/235 dated 20.09.2022, AAP.155/2021/Pt2/28 dated 06.12.2022, AAP.155/2021/Pt/415 dated 31.03.2023, AAP.155/2021/267 dated 02.06.2023 and AAP.155/2021/Pt2/34 dated 18.09.2023;

Whereas, the report of the Inquiry Officer is under examination for a decision of the Authority;

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the case against Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Abul Khair Ilias Noshim Ahmed, ACS for another period of 3 months w.e.f. 04.12.2023 or till further order.
