Whereas, considering the seriousness of the charge, the period of suspension of Shri Anupam Choudhury, ACS (U/S) was extended vide Order No.s: AAP.173/2022/24 dated 31.12.2022, AAP.173/2022/32 dated 31.03.2023, AAP.173/2022/33 dated 30.06.2023, AAP.173/2022/35 dated 16.10.2023, AAP.101/2023/58 dated 29.12.2023 and AAP.101/2023/130 dated 28.03.2024;

Whereas, based on the recommendations of the Review Committee and considering the grave nature of the charge against Shri Anupam Choudhury, ACS (U/S), the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Anupam Choudhury, ACS (U/S), for another period of 3 months w.e.f. 29.06.2024 or till further order.
