**NOTIFICATION**

Dated Dispur, the 31<sup>st</sup> of March, 2023

**No.AAP.155/2021/Pt/415:** Whereas Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S), the then Deputy Secretary to the Govt. of Assam, Transport Department, was placed under suspension w.e.f. 04.12.2021 vide Notification No. AAP 155/2021/08 dated 15.12.2021, subsequent to his arrest on 04.12.2021 in connection with Vigilance PS Case No.05/2021;

Whereas considering the seriousness of the charge, the period of suspension of Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) was extended for a period of 3 (three) months w.e.f. 04.03.2022 vide Order no. AAP. 155/2021/214 dated 22.03.2022, then for a period of another 3 (three) months w.e.f. 04.06.2022 vide Order no. AAP.155/2021/226 dated 12.07.2022, then for a period of another 3 (three) months w.e.f. 04.09.2022 vide Order No. AAP.155/2021/248 dated 17.10.2022 and lastly for another period of another 3 (three) months w.e.f. 04.12.2022 vide Order no. AAP.155/2021/Pt2/28 dated 06.12.2022;

Whereas, departmental proceeding was drawn up against Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) vide Show Cause Notice No. AAP 155/2021/210 dated 14.03.2022;

Whereas Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) has submitted his written statement of defence on 13.09.2022;

Whereas Inquiry Officer appointed by the Disciplinary Authority, vide Order No: AAP. 155/2021/Pt/352 dated 30.12.2022, submitted his report vide Letter No: AAP.02/2023/143 dated 10.03.2023;

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the case against Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S) and considering the seriousness of the charge and also the fact that the report of the Inquiry Officer has to be examined by the Department, so the Review Committee is of the opinion that the reinstatement of Shri Abul Khair Ilias Noshim Ahmed, ACS (U/S), at this point may be prejudiced to the Disciplinary Proceedings already drawn up. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Abul Khair Ilias Noshim Ahmed, ACS for another period of 3 months w.e.f. 04.03.2023 or till further order.
