Sub. : Issuance of Income and Asset Certificates to the aspirants applying for Central/State Government jobs and seats in Educational Institutions under 10% Reservation for Economically Weaker Section (EWS)

Madam/Sir

In inviting a reference to the subject cited above, I am directed to say that Government of India has made provision of 10% Reservation for Economically Weaker Section (EWS) in direct recruitment in civil posts and services in the Government of India of vide OM No.36039/1/2019- ESTT (Res) dated 31.01.2019 (copy enclosed for ready reference).

As per para 4 of the aforesaid OM a person may be identified as EWS if he/she is not covered under the scheme of reservation for SCs, STs and OBCs and whose family's gross annual income is **Rs. 8.00 lakh** and above and does not own/possess any of the following:

1. 5 acres of agriculture land and above
2. Residential flat of 1000 sq. ft and above
3. Residential plot of 100 sq. yards and above in notified municipalities
4. Residential plot of 100 sq. yards and above in areas other than the notified municipalities

As per the Sl. 5 of the GOI's OM No.36039/1/2019- ESTT (Res) dated 31.01.2019, Income and Asset Certificates as per **Annexure I** to the aspirants applying for direct recruitment in civil posts and services in the Government of India after following necessary formalities may be issued.

Government of Assam has also issued two OM Nos. ABP. 7/2019/3 dated 02.02.2019 and ABP. 07/2019/4 dated 10.04.2019 for the Reservation for EWS in posts and services and in Educational Institutions in the Government of Assam. As per sl. 4 of the aforesaid OM a person may be identified as EWS if he/she is not covered under the scheme of reservation for SCs, STs and OBCs and whose family's gross annual income is **Rs. 6.00 lakh** and above and does not own/possess any of the following:

1. 15 bigha of agriculture land and above in rural area
2. 1 bigha of residential land and above in rural area
3. 1.5 katha of land in notified Municipal Corporation/Municipal Board/Town Committee area
4. House of built up area more than 1000 sq. ft and above in notified Municipal Corporation/Municipal Board/Town Committee area

In the interest of convenience of general public and administrative efficiency Circle Officer/Circle Officer (A) of the concerned Revenue Circle are hereby authorized to issue Income and Asset Certificates as per **Annexure I** of aforesaid OMs to the aspirants applying for the Reservation for EWS in posts and services and seats in Educational Institutions in the Central/State Government after following necessary formalities as prescribed in the above mentioned OMs. The Circle Officers will maintain separate registers of certificates issued for Central Government and State Government.
