## NOTIFICATION

The 19th July, 2023

**No. ABP 13/2022/43.-** In exercise of the powers conferred by section 15 of the Assam Direct Recruitment Commissions for Analogous Posts for Class III and Class IV Act, 2021, the Government of Assam is hereby pleased to make the following rules further to amend the Assam Direct Recruitment for Class III and Class IV Analogous Posts Rules, 2022, hereinafter referred to as the principal Rules, in the following manner namely:-

| Short title and commencement | 1. (i) These rules may be called the Assam Direct Recruitment for Class III and Class IV Analogous Posts (Amendment) Rules, 2023.  |
|                              | (ii) They shall come into force on the date of their publication in the Official Gazette.  |
| Amendment of rule 12         | 2. In the principal Rules, in rule 12, for the existing sub-rule (3), the following shall be substituted, namely:-<br>“(3) In the event candidates recommended against lowest Grade pay posts of any category by the Commissions and appointed by Departments concerned fail to join their |

respective posts within the joining time period as specified in the respective Service Rules, the Commissions shall further recommend suitable candidates securing same cut off marks in the respective lowest Grade pay category to the Departments for appointment against those vacant posts having considered the reservation criterion. The list so recommended will be in continuation of the earlier recommended list:

Provided in the event of the Commission being unable to recommend sufficient number of candidates to fill up all the vacancies in a year, it shall, in consultation with the Appointing Authority, repeat the procedure of recruitment for recommending a subsequent list in the year:

Provided further that during the period of validity of an earlier list the Appointing Authority shall not make appointment of any candidate from a subsequent list until all the candidates of that earlier list have been offered the appointment.”.

Amendment of  
rule 19

3. In the principal Rules, in rule 19, after the existing sub-rule (4), the following sub-rule (5) shall be inserted, namely :-  
“(5) The State Government reserves the right to make/ alter/ effect/ modify any change in the Rules at any stage which appear to be necessary to remove any difficulty arising out of a situation in a just and equitable manner not inconsistent with the provisions of the Act, for achieving greater cause of justice and public good.”.
