No.AAP.173/2022/32: Whereas Shri Anupam Choudhury, ACS(U/S), the then Deputy Commissioner, Hojai, was placed under suspension w.e.f 29.09.2022 vide Notification No. AAP.173/2022/1 dated 29.09.2022, for physically assaulting general public in Hojai on 28.09.2022;

Whereas, departmental proceeding was drawn up against Shri Anupam Choudhury, ACS (U/S) vide Show Cause Notice No. AAP.173/2022/22 dated 03.12.2022;

Whereas considering the seriousness of the charge, the period of suspension of Shri Anupam Choudhury, ACS(U/S) was extended for a period of 3 (three) months w.e.f. 29.12.2022 vide Order No: AAP. AAP.173/2022/24 dated 31.12.2022;

Whereas a Review Committee has been constituted to review this case of suspension and after examining the records of the case against Shri Anupam Choudhury, ACS (U/S), and considering the grave nature of the charge against Shri Anupam Choudhury, ACS (U/S), which included tarnishing of the image of the Government of Assam, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Anupam Choudhury, ACS (U/S), for another period of 3 months w.e.f. 29.03.2023 or till further order.


