No AAP.76/2018/91: Whereas Smti Avisika Baruah, ACS, the then Circle Officer, Nazira, Sivasagar was placed under suspension vide No.AAP 76/2018/2 dated 17.03 2018.

Whereas Smti Avisika Baruah, ACS has become Approver in Dibrugarh PS Case No 936/2016 and Smti Avisika Baruah has given her confessional statement U/S 164 Cr P.C before the Judicial Magistrate on 03.8 2018 where she has disclosed the ways and means by which she procured the job of ACS conducted by APSC by managing the then Chairman, APSC and others.

Whereas, considering the seriousness of the case and as the officer has already given her confessional statement regarding procurement of her job by unfair means, it has been decided by the Appointing Authority that re-instatement at this stage may not be in the interest of public service.

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti Avisika Baruah, ACS, who is under suspension, for another 3 (three) months w.e.f. the date of this notification.


