Whereas, departmental proceeding has been drawn up against Shri Bikram Aditya Bora, ACS vide Show Cause Notice No.AAP 155/2021/209 dated 14.03.2022;

Whereas, considering the seriousness of the charges, it has been decided by the Disciplinary Authority that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam is pleased to extend the period of suspension in respect of Shri Bikram Aditya Bora, ACS for a period of 3 (three) months with reference to earlier order dated 15.12.2021.
