Whereas, departmental proceeding was drawn up against Shri Bikram Aditya Bora, ACS (U/S) vide Show Cause Notice No. AAP 155/2021/209 dated 14.03.2022;

Whereas considering the seriousness of the charge the period of suspension of Shri Bikram Aditya Bora, ACS was extended subsequently vide Order No.s: AAP. 155/2021/213 dated 22.03.2022, AAP.155/2021/225 dated 12.07.2022, AAP.155/2021/248 dated 17.10.2022, AAP.155/2021/239 dated 06.12.2022 and AAP.155/2021/263 dated 10.03.2023;

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the cases against Shri Bikram Aditya Bora, ACS and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Bikram Aditya Bora, ACS for a further period of 3 months w.e.f. 04.06.2023 or till further order.
