No.AAP.101/2023/72: Whereas Shri Biswajit Goswami, ACS (U/S), the then CEO, ZP, Dhubri, was placed under suspension w.e.f 21.07.2023 vide Notification No: AAP.83/2023/4 dated 31.07.2023;

Whereas Departmental Proceeding was drawn up against Shri Biswajit Goswami, ACS (U/S), vide Show Cause Notice No. AAP.83/2023/102 dated 08.12.2023;

Whereas considering the seriousness of the charges, the period of suspension of Shri Biswajit Goswami, ACS (U/S), was extended vide Order No.: AAP.101/2023/42 dated 29.11.2023;

Whereas, considering the grave nature of the charge against Shri Biswajit Goswami, ACS (U/S) and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Biswajit Goswami, ACS (U/S), for another period of 3 months w.e.f. 21.01.2024 or till further order.


