**No.AAP.101/2022/142:** Whereas Smti. Barbie Hazarika, ACS (U/S), the then Assistant Commissioner, Kamrup (M) & OSD Secondary Education Department was placed under suspension w.e.f. 02.06.2022 vide Notification No. AAP.101/2022/6 dated 02.06.2022;

Whereas, a departmental proceeding was drawn up against Smti. Barbie Hazarika, ACS (U/S) vide Show Cause Notice No. AAP 101/2022/23 dated 10.06.2022.

Whereas, considering the seriousness of the charges against Smti. Barbie Hazarika, ACS (U/S), the period of suspension of Smti. Barbie Hazarika, ACS (U/S) was extended subsequently vide order Nos. AAP.101/2022/43, dated 21.09.2022, AAP.101/2022/46 dated 12.12.2022, AAP.101/2022/56, dated 24.03.2023 and AAP.101/2022/59, dated 08.06.2023.

Whereas, the Review Committee constituted to review the case of suspension and after examining all the records of the case has recommended extension of suspension of Smti. Barbie Hazarika, ACS (U/S) for another period of 3 months w.e.f. 02.09.2023.

Whereas, considering the seriousness of the charge and also the recommendation of the Review Committee, it has been decided by the Disciplinary Authority that reinstatement at this stage may not be in the interest public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti. Barbie Hazarika, ACS for a further period of 3 months w.e.f. 02.09.2023 or till further order.
