No.AAP.155/2021/Pt2/50: Whereas Smti. Barbie Hazarika, ACS (U/S), the then Assistant Commissioner, Kamrup (M) & OSD Secondary Education Department was placed under suspension w.e.f. 02.06.2022 vide Notification No.AAP.101/2022/6 dated 02.06.2022;

Whereas, Departmental Proceeding was drawn up against Smti Barbie Hazarika, ACS(U/S), vide Show Cause Notice No.AAP 101/2022/23 dated 10.06.2022;

Whereas considering the grave nature of the charge against Smti Barbie Hazarika, ACS(U/S), the period of suspension of Smti Barbie Hazarika, ACS(U/S) was extended subsequently vide Order No.s: AAP.101/2022/43 dated 29.09.2022, AAP.101/2022/46 dated 12.12.2022, AAP.101/2022/56 dated 24.03.2023, AAP.101/2022/59 dated 08.06.2023 and AAP.101/2022/142 dated 18.09.2023

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the cases against Smti Barbie Hazarika, ACS(U/S) and considering the grave nature of the charge, the Review Committee has recommended for extension of her suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam is pleased to extend the period of suspension in respect of Smti Barbie Hazarika, ACS, for another period of 3 (three) months w.e.f. 02.12.2023 or till further order.
