**ORDERS BY THE GOVERNOR**  
**NOTIFICATION**

Dated Dispur, the 10<sup>th</sup> of June, 2024

**No.AAP. 44/2024/13:** Whereas Shri Bikram Aditya Bora, ACS (U/S), the then Deputy Secretary, Bodoland Territorial Region, was placed under suspension w.e.f. 04.12.2021 vide Notification No: AAP.155/2021/07 dated 15.12.2021, subsequent to his arrest on 04.12.2021 in connection with Vigilance PS Case No. 05/2021;

Whereas, Departmental Proceeding was drawn up against Shri Bikram Aditya Bora, ACS (U/S), vide Show Cause Notice No. AAP.171/2022/Pt/190 dated 16.02.2023 on the charges of illegally allotting Govt. land/Forest Land/Ceiling Land to the undeserving beneficiaries;

Whereas another Departmental Proceeding was drawn up against Shri Bikram Aditya Bora, ACS (U/S) vide Show Cause Notice No. AAP. 155/2021/209 dated 14.03.2022 on the charges of committing irregularities in appointment of Gaonbura while serving as CO, Mankachar, South Salmara District;

Whereas considering the seriousness of the charge, the period of suspension of Shri Bikram Aditya Bora, ACS (U/S) was extended subsequently vide Order No.s: AAP.155/2021/213 dated 22.03.2022, AAP.155/2021/225 dated 12.07.2022, AAP.155/2021/248 dated 17.10.2022, AAP.155/2021/239 dated 06.12.2022, AAP.155/2021/263 dated 10.03.2023, AAP.155/2021/266 dated 02.06.2023, AAP.155/2021/Pt2/32 dated 18.09.2023, AAP.155/2021/Pt2/46 dated 22.12.2023 and AAP.26/2024/34 dated 02.04.2024;

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the cases against Shri Bikram Aditya Bora, ACS (U/S) and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of the public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Bikram Aditya Bora, ACS(U/S), for another period of 3 months w.e.f. 04.06.2024 or till further order.
