No.AAP.155/2021/263: Whereas Shri Bikram Aditya Bora, ACS, Deputy Secretary, Bodoland Territorial Region, was placed under suspension w.e.f. 04.12.2021 vide Notification No. AAP 155/2021/07 dated 15.12.2021, subsequent to his arrest on 04.12.2021 in connection with Vigilance PS Case No.05/2021;

Whereas, departmental proceeding was drawn up against Shri Bikram Aditya Bora, ACS (U/S) vide Show Cause Notice No. AAP 155/2021/209 dated 14.03.2022;

Whereas considering the seriousness of the charge the period of suspension of Shri Bikram Aditya Bora, ACS was extended for a period of 3 (three) months w.e.f. 04.03.2022 vide Order No: AAP. 155/2021/213 dated 22.03.2022, then for a period of another 3 (three) months w.e.f 04.06.2022 vide Order No: AAP.155/2021/225 dated 12.07.2022, then for a period of another 3 (three) months w.e.f. 04.09.2022 vide Order No. AAP.155/2021/248 dated 17.10.2022 and lastly for a period of another 3 (three months) vide Order No. AAP.155/2021/239 dated 06.12.2022;

Whereas a Review Committee has been constituted to review this case of suspension and after examining all the records of the cases against Shri Bikram Aditya Bora, ACS and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Bikram Aditya Bora, ACS for a further period of 3 months w.e.f. 04.03.2023 or till further order.
