No.AAP.101/2023/112: Whereas Shri Dhrubajyoti Hatibaruah, ACS (U/S), the then Deputy Secretary to the Gov. of Assam, Indigenous and Tribal Faith & Culture Department, was placed under suspension w.e.f 30.11.2023 vide Notification No: AAP.122/2023/27 dated 30.11.2023;

Whereas, Departmental Proceeding has been initiated against the officer vide Show Cause notice No:AAP.112/2023/1 dated 14.11.2023 and the Review Committee after examining the records available and considering the grave nature of the charges, recommended for extension of the suspension period for a period of 3 (three) months;

Whereas, considering the seriousness of the charges and also the recommendation of the Review Committee, it has been decided by the Disciplinary Authority that reinstatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Dhrubajyoti Hatibaruah, ACS (U/S), for another period of 3 months w.e.f. 01.03.2024 or till further order.
