No.AAP.101/2023/141: Whereas Shri Dhiraj Kumar Jain, ACS (U/S), the then Deputy Secretary to the Govt. of Assam, Election Department and Joint CEO, Assam, was placed under suspension w.e.f. 30.11.2023 vide Notification No: AAP.122/2023/29 dated 30.11.2023;

Whereas, Departmental Proceeding has been initiated against the officer vide Show Cause notice No.AAP.116/2023/1 dated 14.11.2023; and

Whereas, considering the seriousness of the charges, the period of suspension of Shri Dhiraj Kumar Jain, ACS (U/S) was extended subsequently vide Order No. AAP.101/2023/114, dated 14.03.2024; and

Whereas, considering the grave nature of the charges against Shri Dhiraj Kumar Jain, ACS (U/S) and based on the recommendation of the Review Committee, it has been decided by the Disciplinary Authority that reinstatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Dhiraj Kumar Jain, ACS (U/S), for another period of 3 months w.e.f. 01.06.2024 or till further order.
