Whereas, Departmental Proceeding has been contemplated against the officer and the Review Committee after examining the records available and considering the seriousness of the charges which involves corruption and moral turpitude, recommended for extension of the suspension period;

The Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Dipankar Kalita, ACS (U/S), for another period of 3 months w.e.f. 25.01.2024 or till further order.


