**ORDER**

**Subject :** **Inter cadre deputation of IAS officers serving in Government of Assam-reg.**

Reference is drawn to Department of Personnel and Training, Government of India's O.M. No.13017/16/2003-AIS.I dated 05-09-2017 regarding consolidated guidelines on Inter-cadre deputation, according to which All India Services lady officers borne on a North East Cadre may be allowed to go on Inter Cadre deputation including her Home State after completion of 6 (six) years of actual service in the North East and male officers borne on a North East Cadre may be allowed to go on Inter Cadre deputation to other cadres including Home State after completion of 9 (nine) years of actual service in the North East and not being in SAG scale.

Reference is also drawn to Department of Personnel and Training, Government of India's letter No.13017/10/2021-AIS-I dated 08-09-2021 which states that only proposals received through proper channel along with consent of the parent cadre of the officer would be entertained by Department of Personnel and Training.

However, in the context of shortage of middle level IAS officers serving in the Government of Assam, no further proposals for Inter-cadre deputation shall be considered for the next 5 (five) years or until further orders.
