**No.AAP.26/2024/66:** Whereas Shri Kisan Kumar Sharma, ACS (U/S), the then Joint Secretary to the Govt. of Assam, Home and Political Department, was placed under suspension w.e.f 29.10.2022 vide Notification No. AAP.183/2022/4 dated 31.10.2022;

Whereas, Departmental Proceeding was drawn up against Shri Kisan Kumar Sharma, ACS (U/S) vide Show Cause Notice No. AAP.183/2022/Pt/91 dated 03.04.2023;

Whereas considering the seriousness of the charge, the period of suspension of Shri Kisan Kumar Sharma, ACS (U/S) was extended vide Order No.s: AAP.183/2022/92 dated 02.02.2023, AAP.183/2022/113 dated 26.04.2023, AAP.183/2022/115 dated 03.08.2023, AAP.183/2022/119 dated 25.10.2023 and AAP.101/2023/73 dated 19.02.2024;

Whereas, considering the grave nature of the charge against Shri Kisan Kumar Sharma, ACS (U/S) and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension from service in respect of Shri Kisan Kumar Sharma, ACS (U/S), for another period of 3 (three) months w.e.f. 29.04.2024 or till further order.
