Whereas, Departmental Proceeding was drawn up against Shri Kumar Surajeet Bora, ACS (U/S), vide Show Cause Notice No. AAP.188/2022/16 dated 14.03.2023;

Whereas, considering the grave nature of the charge against Shri Kumar Surajeet Bora, ACS (U/S) and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Kumar Surajeet Bora, ACS (U/S), for another period of 3 months w.e.f. 12.12.2023 or till further order.
