No.AAP.101/2023/129: Whereas Shri Kumar Surajeet Bora, ACS (U/S), the then Deputy Secretary to the Govt. of Assam, Border Protection and Development Department, was placed under suspension w.e.f 12.09.2023 vide Notification No: AAP.188/2022/37 dated 08.09.2023;

Whereas, Departmental Proceeding was drawn up against Shri Kumar Surajeet Bora, ACS (U/S), vide Show Cause Notice No. AAP.188/2022/16 dated 14.03.2023;

Whereas, considering the seriousness of the charge, the period of suspension of Shri Kumar Surajeet Bora, ACS (U/S), was extended subsequently vide Order No.:AAP.101/2023/64 dated 29.12.2023;

Whereas, based on the recommendations of the Review Committee and considering the grave nature of the charge against Shri Kumar Surajeet Bora, ACS (U/S), the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Kumar Surajeet Bora, ACS (U/S), for another period of 3 months w.e.f. 12.03.2024 or till further order.


