Whereas, considering the grave nature of the charge against Shri Lakshya Jyoti Das, ACS (U/S) and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Lakshya Jyoti Das, ACS (U/S), for another period of 3 months w.e.f. 31.04.2024 or till further order.


