Whereas on examination of the report and documents furnished by the SP, CM's Special Vigilance Cell, Departmental Proceeding against Shri Munindra Bardoloi, ACS (U/S) is contemplated;

Whereas, considering the grave nature of the charge against Shri Munindra Bardoloi, ACS (U/S), and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Munindra Bardoloi, ACS (U/S), for a period of 3 months w.e.f. 18.06.2023 or till further order.
