The appellant Shri Mukul Kathar, ACS is present. He has prayed for 1<sup>st</sup> Appeal hearing in context of his RTI application dated 16-07-2018. Shri Kathar has stated that the information provided by the then SPIO, Personnel(A) Department vide letter no. **AAP.53/2018/28 dated 18-08-2018** appeared to be incomplete and unsatisfactory in nature and for which reason the 1<sup>st</sup> Appeal petition has been preferred.

The SPIO Smti Sharmila Baishya, ACS accompanied by Ankita Boruah, Jr. AA of the department is present. From perusal of records, it appears that information sought for by Shri Mukul Kathar relating to query No. (a), (e), (i) and (j) were already agreed upon by the Appellant.

It further appears that certain information provided by the then SPIO of the Personnel (A) Department seems to be vague in nature. Therefore, the SPIO is directed to provide specific replies available against the RTI queries wherever there is no bar of law in providing information under the provision of RTI Act 2005.

As against queries where information cannot be disclosed to the appellant, mention may be made of the Sections under RTI Act 2005, which exempts from disclosure of such information to the applicant.

With the above order, the 1<sup>st</sup> Appeal petition dated **07-06-2019** is hereby disposed off.
