No.AAP. 58/2023/73: Whereas Shri Mukul Kathar, ACS(U/S), the then Joint Secretary to the Govt. of Assam, Tea Tribes Welfare Department, was placed under suspension vide Notification No: AAP.58/2023/46 dated 25.08.2023;

Whereas, Departmental Proceeding was drawn up against Shri Mukul Kathar, ACS (U/S), vide Show Cause Notice No. AAP.58/2023/48 dated 28.08.2023;

Whereas considering the seriousness of the charge, the period of suspension of Shri Mukul Kathar, ACS (U/S) was extended vide Order No.s: AAP.58/2023/67 dated 18.11.2023 and AAP.101/2023/74 dated 19.02.2024;

Whereas, considering the grave nature of the charge against Shri Mukul Kathar, ACS(U/S) and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of the public service;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Mukul Kathar, ACS (U/S), for another period of 3 months w.e.f. 25.05.2024 or till further order.


