**NOTIFICATION**

**No. ABP. 86/2007/Pt-I/27:** In exercise of the powers conferred by Article 318 of the Constitution of India, the Governor of Assam is hereby pleased to make the following Regulations, which is issued as per approval from the Cabinet as Additional Item No. 19 held on 07/12/2022 in the eCF No. 238979, further to amend the Assam Public Service Commission Regulation, 1951 (as amended), namely:-

Short title and commencement

1. (1) These Regulations may be called the Assam Public Service and Commission (Amendment) Regulations, 2022.
- (2) They shall come into force on the date of its publication in the Official Gazette.

Substitution of Regulation 7

In the Assam Public Service Commission Regulations, 1951 (as amended), for the existing provisions of regulation no 7, the following shall be substituted, namely:-

- 7 (i) The Chairman of the Commission shall receive a pay in the scale of Rs. 2,25,000/- (fixed) per mensem and the Member shall receive his pay in the scale of Rs. 1,82,200 to Rs. 2,24,100/- per mensem.

Provided that in case of the appointment as the Chairman or a Member a person who had retired from regular service under the Central or State Government, or a local body or a University or any other body, wholly or partly owned or controlled by the Government and who is in receipt of or has become entitle to receive any retirement benefits by way of pension, gratuity, Contributory Provident Fund or otherwise, the pay specified in these regulations or the pay last drawn if that be higher, shall be reduced by the gross amount of pension (including any portion of the pension which may have been commuted) and the pension equivalent of other forms of retirement benefits, if any, or at the option of the person, the pension may be kept in abeyance, in which case the Chairman or the Member shall be allowed to draw the full pay and allowance as provided in this clause, subject to the provisions of Chapter-X of the Assam Service (Pension) Rules, 1969 and DCRG Rules, 1958:

Provided further that a person who at the time of his appointment as Chairman or a Member of the Commission was in the regular service of the Central or State Government or a local body or a University or any other body wholly or partly owned or controlled by the Government, is appointed as the Chairman or a Member of the Commission (his/her pay in Pay Band would be fixed in such a manner that the sum of pay in pay band and Grade pay would be equal to his last pay drawn his last pay drawn at the time of superannuation from Government service). The Chairman and Members of the Commission shall be entitled to get the protection of the pay drawn by him in the service, in accordance with the provisions of the Fundamental Rules and Subsidiary Rules.

**Explanation:-**

For the purpose of this Regulation:-

- (a) Service under the Union or a State public service commission shall be considered as service under the Government;

- (b) The term "University" shall include any institution for higher education wholly or partly financed by the Central Government or any State Government or both and deemed to be a University under the University Grants Commission Act, 1956,
- (c) The term "any other body wholly or partly owned or controlled by the Government" shall include a government company as defined in the Companies Act, 1956 and any other statutory body, whether incorporated or not, in which the Central Government or any State Government or both has a controlling interest on its nominees, substantial control over its working;
- (ii) The Chairman and other Members shall receive Dearness Allowance at the rates applicable from time to time to the Central Government employees;
- (iii) (a) The Chairman and other Members shall be entitled to the facilities for medical treatment and accommodation in Hospitals as admissible to the Secretaries to the Government of Assam,
- (b) The Chairman and other Members shall be entitled to the facilities of House Rent allowance as admissible to State Government employees.
