**OFFICE MEMORANDUM**

Subject : Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services and admission in Educational Institutions in the Government of Assam.

Reference is drawn to Personnel (B) Department's O.M.No.ABP.07/2019/3 dated 2<sup>nd</sup> February, 2019, O.M. No. ABP.07/2019/4 dated 10<sup>th</sup> April, 2019, O.M. No. ABP. 07/2019/16 dated 31<sup>st</sup> December, 2019 and O.M. No. ABP.129/2018/152 dated 13<sup>th</sup> April, 2022 regarding Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services and admission in Educational Institutions in Government of Assam according to which persons whose family owns or possesses the following assets shall be excluded from being identified as EWS irrespective of family income:

- i) 15 Bigha of agricultural land and above in rural areas.
- ii) 1 Bigha of residential land and above in rural areas.
- iii) 4320 sq. ft. of land in notified Municipal Corporation/Municipal Board/Town Committee area.
- iv) House of built up area more than 1000 sq. ft. and above in notified Municipal Corporation/Municipal Board/Town Committee area.

Now, in the interest of public service and in partial modification of this Department's earlier **O.M. No. ABP.07/2019/4 dtd. 10.04.2019**, the possession of assets, irrespective of family income, is enhanced by substituting Points (i) to (iv) of 4.1 of para 4 of the said O.M. as follows with immediate effect:

- i) 30 Bigha (4,32,000 sq. ft.) of agricultural land and above in rural areas.
- ii) 2 Bigha (28,800 sq. ft.) of residential land and above in rural areas.
- iii) 8640 sq. ft. of land in notified Municipal Corporation/Municipal Board/Town Committee area.
- iv) House of built up area 2000 sq. ft. and above in notified Municipal Corporation/Municipal Board/Town Committee area.
