Whereas, Shri A. Agnihotri, IAS was appointed as Enquiry Officer to enquire into the charges against Shri Pulak Mahanta, ACS vide No.AAP 198/2018/69 dated 03.12.2018 and the Enquiry Officer has also submitted its report.

Whereas, considering the seriousness of the charge of the departmental proceeding, it has been decided by the Disciplinary Authority that re-instatement at this stage may not be in the interest of fair conclusion of the departmental proceeding

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Pulak Mahanta, ACS for another 3 (three) months or till conclusion of the departmental proceeding, whichever is earlier.
