Whereas departmental proceeding against Shri Prasanta Protim Kathkotia, ACS was drawn up vide No.AAP 197/2018/14 dated 05.11.2018.

Whereas, Shri A. Agnihotri, IAS was appointed as Enquiry Officer to enquire into the charges against Shri Prasanta Protim Kathkotia, ACS vide No.AAP 197/2018/39 dated 03.12.2018 and the Enquiry Officer has also submitted its report.

Whereas, considering the seriousness of the charge of the departmental proceeding, it has been decided by the Disciplinary Authority that re-instatement at this stage may not be in the interest of fair conclusion of the departmental proceeding.

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Prasanta Protim Kathkotia, ACS for another 3 (three) months or till conclusion of the departmental proceeding, whichever is earlier


