No.AAP.174/2022/26: Whereas Shri Roktim Boruah, ACS (U/S), the then Additional Deputy Commissioner, Hojai, was placed under suspension w.e.f 29.09.2022 vide Notification No: AAP.174/2022/1 dated 29.09.2022, for physically assaulting general public in Hojai on 28.09.2022;

Whereas, departmental proceeding was drawn up against Shri Roktim Boruah, ACS (U/S) vide Show Cause Notice No. AAP.174/2022/22 dated 06.12.2022;

Whereas a Review Committee has been constituted to review this case of suspension and after examining the records of the case against Shri Roktim Boruah, ACS (U/S), and considering the grave nature of the charge against Shri Roktim Boruah, ACS (U/S), which included tarnishing of the image of the Government of Assam, it has been decided by the Review Committee that re-instatement at this stage may not be in the interest of public;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Roktim Boruah, ACS (U/S), for a period of 3 months w.e.f. 29.12.2022 or till further order.


