No.AAP.108/2021/46 : Whereas Shri Saibar Rahman, ACS, Deputy Secretary to the Govt of Assam, Welfare of Minorities Development Deptt was placed under suspension w.e.f. 24.08.2021 vide Notification No.AAP 108/2021/04 dated 10.9.2021, subsequent to his arrest on 24.08.2021 in Vigilance PS Case No.03/2021;

Whereas, departmental proceeding was drawn up against Shri Saibar Rahman, ACS vide Show Cause Notice No.AAP 108/2021/34 dated 08.11.2021;

Whereas considering the seriousness of the charge the period of suspension of Shri Saibar Rahman was extended for a period of 3 (three) months w.e.f. 24.11.2021 vide Order no.AAP 108/2021/38 dated 22.11.2021;

Whereas, Shri Saibar Rahman, ACS has not submitted reply to the Show Cause Notice dated 08.11.2021 and has also not informed the Disciplinary Authority about his release from judicial custody;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Saibar Rahman, ACS for further period of 3 months w.e.f. 24.02.2022 or till further order.
