Whereas, departmental proceeding has been drawn up against Shri Saibar Rahman, ACS vide Show Cause Notice No.AAP 108/2021/34 dated 08.11.2021;

Whereas, considering the seriousness of the charges, it has been decided by the Disciplinary Authority that re-instatement at this stage may not be in the interest of public service;

Now, therefore, the Governor of Assam is pleased to extend the period of suspension in respect of Shri Saibar Rahman, ACS for further period of 3 (three) months w.e.f 24.11.2021 or till further orders.
