Whereas, considering the grave nature of the charge against Smti. Sukanya Bora, ACS (U/S), and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti. Sukanya Bora, ACS (U/S), for a period of 3 months w.c.f. 18.06.2023 or till further order.vvvvvvvv
