**No.AAP.44/2024/19:** Whereas Smti. Sukanya Bora, ACS (U/S), the then Additional Deputy Commissioner, Kamrup (M), was placed under suspension w.e.f 18.03.2023 vide Notification No. AAP.38/2023/2 dated 18.03.2023;

Whereas, Departmental Proceeding was drawn up against Smti. Sukanya Bora, ACS (U/S) vide Show Cause Notice No: AAP.38/2023/232 dated 13.09.2023;

Whereas, considering the seriousness of the charge, the period of suspension of Smti. Sukanya Bora, ACS (U/S), was extended subsequently vide Order No.:AAP.38/2023/4 dated 09.06.2023, AAP.101/2023/38 dated 04.10.2023, AAP.101/2023/61 dated 29.12.2023 and AAP.101/2023/126 dated 28.03.2024;

Whereas, based on the recommendations of the Review Committee and considering the grave nature of the charge against Smti. Sukanya Bora, ACS (U/S), the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti. Sukanya Bora, ACS (U/S), for another period of 3 months w.e.f. 18.06.2024 or till further order.


