**No.AAP.101/2023/60**: Whereas Smti. Sharmistha Borah, ACS (U/S), the then Deputy Secretary to the Govt. of Assam, Home and Political Department, was placed under suspension w.e.f 18.03.2023 vide Notification No. AAP.37/2023/2 dated 18.03.2023;

Whereas Departmental Proceeding was drawn up against Smti. Sharmistha Borah, ACS (U/S) vide Show Cause Notice No: 37/2023/124 dated 04.08.2023;

Whereas considering the seriousness of the charge, the period of suspension of Smti. Sharmistha Borah, ACS (U/S), was extended subsequently vide Order No.: AAP. 37/2023/11 dated 09.06.2023 and AAP. 101/2023/35 dated 04.10.2023;

Whereas, considering the grave nature of the charge against Smti. Sharmistha Borah, ACS (U/S), and based on the recommendations of the Review Committee, the Disciplinary Authority has decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Smti. Sharmistha Borah, ACS (U/S), for another period of 3 months w.e.f. 18.12.2023 or till further order.
