No.AAP. 76/2018/Pt/8: Whereas Shri Sanjan Phukan, ACS became Approver in Dibrugarh PS Case No.936/2016 and he gave his confessional statement involving him and others in procuring the job of ACS by unfair means.

Whereas Shri Sanjan Phukan, ACS, the then Assistant Commissioner, Gohpur, Sonitpur was placed under suspension vide No.AAP 210/2018/2 dated 20.11.2018.

Whereas, the suspension period was extended for 3 (three) months w.e.f. 22/04/2019 vide Notification No.AAP 210/2018/Pt/4 dated 22.04.2019 and for another 3 (three) months w.e.f. 22/7/2019 vide Notification No.AAP 76/2018/Pt/6 dated 01.8.2019

Whereas, considering the seriousness of the case and as the officer has already given his confessional statement regarding procurement of his job by unfair means, it has been decided by the Appointing Authority that re-instatement at this stage may not be in the interest of public service.

Now, in continuation of the Notification No.AAP 76/2018/Pt/6 dated 01.8.2019, the Governor of Assam is pleased to extend the period of suspension in respect of Shri Sanjan Phukan, ACS, for a further period of 3 (three) months or till further orders.


