## ORDERS BY THE GOVERNOR NOTIFICATION

No.AAP.108/2021/117: Whereas Shri Saibar Rahman, ACS(U/S), the then Deputy Secretary to the Govt. of Assam, Welfare of Minorities Development Department was placed under suspension w.e.f. 24.08.2021 vide Notification No. AAP 108/2021/04 dated 10.09.2021, subsequent to his arrest on 24.08.2021 in Vigilance PS Case No.03/2021;

Whereas, Departmental Proceeding was drawn up against Shri Saibar Rahman, ACS (U/S) vide Show Cause Notice No. AAP 108/2021/34 dated 08.11.2021;

Whereas, considering the seriousness of the charge, the suspension period of Shri Saibar Rahman was extended subsequently vide Order No.s: AAP.108/2021/38 dated 22.11.2021, AAP.108/2021/46 dated 22.02.2022, AAP.108/2021/76 dated 12.07.2022, AAP.108/2021/79 dated 20.09.2022, AAP.108/2021/89 dated 24.11.2022, AAP.108/2021/110 dated 20.02.2023 and AAP.108/2021/114 dated 31.05.2023. His suspension period will now end on 23.08.2023;

Whereas, Shri Saibar Rahman, ACS (U/S) submitted reply to the Show Cause Notice dated 08.11.2021 on 22.11.2022 wherein he has not admitted to the charges, hence, the Disciplinary Authority decided to hold an enquiry into the charges framed against him by appointing an Inquiring Authority and the report of the Inquiring Authority is awaited;

Whereas a Review Committee has been constituted to review the case of suspension and after examining all the records of the cases against Shri Saibar Rahman, ACS (U/S) and considering the seriousness of the charge which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye;

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Saibar Rahman, ACS (U/S) for a further period of 3 (three) months w.e.f. 24.08.2023 or till further order.
