No.AAP.108/2021/110: Whereas Shri Saibar Rahman, ACS(U/S), the then Deputy Secretary to the Govt. of Assam, Welfare of Minorities Development Department was placed under suspension w.e.f. 24.08.2021 vide Notification No. AAP 108/2021/04 dated 10.09.2021, subsequent to his arrest on 24.08.2021 in Vigilance PS Case No.03/2021;

Whereas, Departmental Proceeding was drawn up against Shri Saibar Rahman, ACS

(U/S) vide Show Cause Notice No. AAP 108/2021/34 dated 08.11.2021;

Whereas, considering the seriousness of the charge the period of suspension os Shri Saibar Rahman was extended for a period of 3 (three) months w.e.f. 24.11.2021vide Order No. AAP.108/2021/38 dated 22.11.2021, then for a period of another 3 (three) months w.e.f. 24.02.2022 vide Order No. AAP.108/2021/46 dated 22.02.2022, subsequently for a period of another 3 (three) months w.e.f. 24.05.2022 vide Order No. AAP.108/2021/76 dated 12.07.2022, then for a period of another 3 (three) months w.e.f. 24.08.2022 vide Order No. AAP.108/2021/79 dated 20.09.2022 and lastly for a period of another 3 (three) months w.e.f. 24.11.2022 vide Order No. AAP.108/2021/89 dated 24.11.2022;

Whereas, Shri Saibar Rahman, ACS (U/S) submitted reply to the Show Cause Notice dated 08.11.2021 on 23.11.2022 which was examined by the Disciplinary Authority and found it not to be satisfactory and decided to hold an enquiry into the charges framed against him by appointing an Inquiring Authority;

Whereas, an Inquiring Authority has been appointed vide order dated 30.01.2023 and

the report of the Inquiring Authority is awaited;

Whereas a Review Committee has been constituted to review the case of suspension and after examining all the records of the cases against Shri Saibar Rahman, ACS (U/S) and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The Disciplinary Authority has hence decided that re-instatement at this stage may not be in the interest of public service and may cause embarrassment to the Government in the public eye:

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Saibar Rahman, ACS (U/S) for a further period of 3 months w.e.f.

24.02.2023 or till further order.
