Whereas, considering the seriousness of the case and as the officer has already given his confessional statement regarding procurement of his job by unfair means, it has been decided by the Appointing Authority that re-instatement at this stage may not be in the interest of public service

Now, therefore, the Governor of Assam, is pleased to extend the period of suspension in respect of Shri Sanjan Phukan, ACS, who is under suspension, for another 3 (three) months w e.f. the date of this notification.


