

This is regarding the Civil Services (Preliminary) Examination, 2021. I am to inform you in this connection that the online application form for this Examination is available on the Commission's Website for the aspirants during the period from 4th March to 24th March, 2021.

2. As per the Rules of the Examination, as notified by the Government (DoP&T), the candidates claiming reservation under the SC/ST/OBC/EWS/PwBD categories are required to have category certificates issued prior to the closing date of application i.e. 23rd March, 2021 (tomorrow).

3. It is to mention in this respect that number of representations have been received from the aspirants, especially claiming the reservation under OBC/EWS categories, that they are facing huge difficulties in obtaining the requisite category certificates due to various reasons including Elections-related work/non-availability of officers concerned/strike by employees/covid-19 pandemic, etc.
