Pension papers has not been forwarded to the Accountant General, Assam in time for finalization of his pension and D.C.R G as Departmental Proceeding was pending against him.

Departmental Proceeding against Shri Basudev Das ACS (Retd.) is dropped vide this departments letter No AAP 147/2014/231 dated 5 11 15 by imposing penalty of stoppage of one annual increment. ( copy enclosed) However, the officer filed writ petition before the Hon'ble Guwahati High Court bearing no W.P (C) 854/2016 against the said order and in pursuance of the order passed by the Hon'ble Guwahati High Court the said order has been stayed vide this departments letter No.AAP.53/2016/96 dated 15.3.16 ( copy enclosed).

The matter was consulted with Judicial Department and it has conveyed no objection for finalization of the pension & other retirement Pension papers in respect of Shri Basudev Das ACS (Retd.) as communicated vide their U.O No 615/19 dated 17 19.

You are requested to verify it, there is any outstanding liabilities pending against the officer and if so to make necessary adjustment against the amount of DCRG due to him.

An application for Commutation of Pension is also forwarded herewith for furnishing the Admissibility Report to the Pension & Public Grievances Department at the earliest.
