
In cancellation of this Department's earlier sanction letter bearing No. AAA.52/95/105 dated 05-02-2019, I am directed to convey the sanction of the Governor of Assam to the grant of a Temporary Advance of Rs. 2,54,000/- (Rupees two lakhs fifty four thousand) only to Shri Joydeep Shukla, ACS, Deputy Secretary to the Govt. of Assam, GAD & OSD, Assam Bhawan, New Delhi from credit of his GPF Account No. LR-12672 to defray the expenses in connection with medical treatment of self.




