With reference to the above, I am directed to inform you that as per records provided by Irrigation Department (HSLC Admit Card/Gradation list) and computation of date of birth in pursuance of general clarification provided by the Finance Departments OM No.FEG26/2012/29 dated 31/10/2012, you are due for retirement w.e.f. **28/02/2019** on attaining the age of superannuation.

I am, therefore, to request you kindly to submit your Pension Papers in the prescribed Form in duplicate after duly filling in the same so as to enable this Department to process for facilitating you to get your Pensionary Benefits on time. The Pension papers including application for final withdrawal of GPF account may also be downloaded from the website Assam Online Portal.

While submitting the Pension Papers, you are requested kindly to indicate whether you have availed of House Building Advance / Motor Car Advance / Motor Cycle or Scooter Advance / Computer Advance etc. and, if so, whether there are any outstanding liabilities pending against you (Principal amount alongwith interest). You are also requested to furnish the Clearance Certificate issued by the Accountant General, if no outstanding amount is pending. A "No Demand Certificate" from the Estate Officer / Executive Engineer, Public Works Department may also kindly be furnished in case you are occupying Govt. accommodation.

You are also requested to furnish a copy of G.P.F. statement issued by the Accountant General (A&E), Assam with your pension papers. It should be mentioned that in term of the provisions of Rule 4B of the GPF (Assam Service) (Amendment) Rules 1994, the recovery of GPF subscription should be stopped before 3 months of the date of retirement of a subscriber.
