- (5) Ensure that all required papers (specimen signature in a separate sheet of paper, duly attested by a Govt. servant), two slips per set of Pension Papers indicating height and personal identification mark duly attested, clearance certificate from Accountant General, No Demand Certificate, if need be and option letter regarding medical scheme and joint photographs (3 copies per set) are submitted as laid down in Form-5 and Form-7.
