The Governor of Assam, therefore, is pleased to withdraw the service of Smti Avisika Baruah from Revenue & Disaster Management Department and pending initiation of departmental proceeding place her under suspension under sub rule 1(c) of Rule 6 of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect and until further orders.
