ORDERS BY THE GOVERNOR  
NOTIFICATION

Whereas Shri Mrinal Gohain was appointed as an officer of the Assam Civil Service Class-I (Junior Grade) vide Notification No.AAP 104/91/96 dated 14.5.1992.

Whereas Shri Mrinal Gohain, the then Programme Officer, DPEP, who had applied for lien, was allowed to retain his quasi lien in ACS for 3 (three) years with effect from the date of his release from DPEP vide No.AAA 86/92/63 dated 16/06/2001 ;

Whereas Shri Mrinal Gohain was released w.e.f. 02/7/2001 from the O/o the State Project Director, District Primary Education Programme vide No.DPEP/ESTT/52/95 dated 30.6.2001 to join as Programme Manager in 'Action Aid India' an international NGO, at its Regional office, Guwahati.

Whereas Shri Mrinal Gohain was requested vide this department's letter No.AAA 86/92/66 dated 30.12.2006 to inform this department about his intention to revert to the parent department as the lien granted to him w.e.f 02/7/2001 to 01/7/2004 had expired:

Whereas as per instruction contained in Finance department's OM No.FEG 65/69/108 dated 31.12.1987 and OM No.FEG 11/97/1 dated 23.12.1997 the lien of the Government employee appointed elsewhere shall be granted for a maximum period of 3 years after which the Government employee shall either revert to his parent department or shall resign from the parent post and the quasi lien shall stand terminated and he will have no claim whatsoever in the parent post:

Whereas Shri Mrinal Gohain neither reverted to his parent department nor had he resigned from Assam Civil Service;

Therefore, the Governor of Assam is pleased to order that Shri Mrinal Gohain is deemed to have been discharged from Assam Civil Service w.e.f. from the date of expiry of his lien i.e 02/7/2004.


