No.AAP 197/2018/6: Whereas it is reported by the Home & Political Department vide their U/O No.HMA 19021/6/2018-Political-A dated 20/10/2018 that there was a breach of protocol during the visit of the Hon'ble Chief Justice of India to Kamakhya Temple, Guwahati on 17/10/2018 and that there was a lack of co-ordination for smooth and hassle free visit of the Hon'ble Chief Justice of India to Kamakhya Temple on that day and whereas the Government has viewed the matter very seriously and decided to place Shri Prasanta Pratim Kathkatia, ACS (DR-99), Additional Deputy Commissioner, Kamrup (Metro), under suspension, who was on duty at Kamakhya Temple during the said visit of the Hon'ble Chief Justice of India, in File No.HMA 19021/6/2018-Political-A of Home & Political Department.

Now, therefore, pending initiation of Departmental Proceeding, Shri Prasanta Pratim Kathkatia, ACS, Additional Deputy Commissioner, Kamrup (Metro) is placed under suspension under Rule 6(1)(a) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.
