Whereas, the Government has considered this as a serious misdemeanor on the part of Shri Pulak Mahanta, ACS, ADC, Kamrup (M).

Now, therefore, pending initiation of Departmental Proceeding, Shri Pulak Mahanta, ACS, Additional Deputy Commissioner, Kamrup (Metro) is placed under suspension under Rule 6(1)(a) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.
